Liability and insurance

The dog owner confirms that valid dog liability insurance is in place and assumes full responsibility for any damage caused by themselves or their dog. Pfotenpfad Hundesitting cares for the dogs entrusted to it with the greatest possible care. For illness, injury or loss of a dog during care, Pfotenpfad Hundesitting is liable only where a breach of due care or gross negligence has been proven. In the event a veterinary visit becomes necessary due to illness or accident during care, the dog owner bears the resulting costs. The dog owner will be contacted before, or as soon as possible after, the veterinary visit.

Health and vaccination status

The dog owner confirms that the dog is healthy, free of contagious diseases and fully vaccinated (combination vaccination; kennel cough and rabies recommended) and is dewormed regularly. Bitches in heat must be registered at least 5 days in advance. Contagious diseases must be reported immediately; care cannot be guaranteed during such periods.

Drop-off and pick-up times

The dog is dropped off and picked up in accordance with the opening hours or as individually arranged with Pfotenpfad Hundesitting. Any delays must be reported immediately by telephone.

Cancellation

The cancellation terms set out in the current price list apply. Cancellation fees are due immediately, regardless of the reason for cancellation.

Payment

Payment is made in cash or by invoice, at the latest when the dog is handed over or before the start of holiday care. The prices of the current Pfotenpfad Hundesitting price list apply.

Photo and video material

Photos and video recordings may be taken in which your dog is recognisable (e.g. for social media). If you do not wish these to be published, please inform me in writing.
